4. Duly filled in & attested "**Attestation Form**" and duly filled in "**Bio-data Form**", (downloaded from the website of the Commission).
5. **One set** of Xerox copies of Published Research Papers.

The candidate (s) shall be allowed to face the interview subject to fulfillment of their eligibility criterion in all respect after completion of verification of documents.

It is also made clear that the candidature of these candidates for the recruitment is purely provisional.
