Applications are invited from eligible local candidates for filling up **25 (twenty-five)** posts of **Specialists (Senior Grade)** on **temporary-regular basis** in **Level-17** of the Pay Matrix under the Sikkim State Specialists Wing of the Sikkim State Health Service, Government of Sikkim, through **Direct Recruitment**. All applications are to be made online at the Commission's website www.spscskm.gov.in

3. ELIGIBILITY CONDITIONS:

(A) Minimum Educational Qualification:

(a)	A Bachelor of Medicine and Bachelor of Surgery (MBBS) Degree from any MCI recognised university, AND
(b)	Completed rotatory internship of 01 (one) year from an institution recognised by the Medical Council of India (MCI), AND
(c)	Registered with the Medical Council of India or Medical Council of State, AND
(d)	Post-Graduate Degree in Clinical, Para-clinical and Pre-clinical subjects in any one of the 09 (nine) specific specialities mentioned in para 1 above.

(B) Other Qualifications:

(a)	Should have knowledge of any of the State Languages.
(b)	Should be conversant with customs and usages of Sikkim.

(C) Age Limit:

Should have attained the age of 21 years , but should not have exceeded 50 years as on 31/01/2022 , in terms of Notification No: 154/GEN/DOP dated: 05/12/2018.

(D) Required Documents:

(a)	Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.		
(b)	Should have Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim.		
(c)	No Objection Certificate from the Head of Department in case of employed candidate.	(d)	Marital Status certificate (for female candidates). In case of married female candidate, COI/SSC of Husband should be provided.

4. **SCHEME OF EXAMINATION:** The Candidates are advised to refer to **APPENDIX - I** for Detailed Scheme and Syllabus for the Examination. The syllabus can be downloaded from the Sikkim Public Service Commission website. **Please note that conduct of the written examination will be governed by sub-rule (7) under rule 7 of the Sikkim State Health Service Rules, 1993. The total no. of posts advertised to be considered for implementation of the said rule will be 25 (twenty-five).**
5. Candidate should go through the advertisement and read the instructions provided on the website carefully before applying online. Applications received through any other mode shall not be accepted and shall be summarily rejected.
6. The candidates are advised to apply online from our website <http://spscsm.gov.in/> on or before the stipulated date and time. Application submitted thereafter will not be accepted and SPSC shall not be responsible for the same.
7. **Rejection list of candidates who do not qualify for the post as per the advertised criteria will be uploaded in the SPSC website on the stipulated date and if any of the rejected candidates have reservation on rejection of application, they should submit their grievances along with justification to the office of the Controller, SPSC within the stipulated period.**
8. Application fee amounting to Rs 150/- only may be paid online through Net Banking or credit and debit card, (Visa/MasterCard). The amount once deposited shall not be refunded or adjusted against any other purpose.
9. e-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same shall be published by the Commission in the official website of the Commission.
10. Candidates are directed to bring a Photo Identity proof like (Aadhaar Card, Voters Card, Driving License) along with valid e-Admit cards to the examination centre for proof of identity.
11. Those candidates who qualify in the written examination will be called for the scrutiny of documents and viva-voce. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.
12. No TA/DA is admissible for attending the written examination / viva-voce.
13. Admission to all the stages of examination for which candidates are admitted by the Commission viz. Written Examination and Viva-voce shall be purely provisional and subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfil any of the eligibility conditions, their candidature for the post shall be cancelled by the Commission without notice.
14. The Commission shall entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
15. **Any further instructions/Corrigendum/Addendum shall be uploaded only on Sikkim Public Service Commission website.**
