NOTE:

- I. The numbers of vacant posts indicated above are provisional and subject to the change without any notice.
 - II. Out of the 93 vacancies (including 9 backlog vacancies for SC, ST and OBC), 04 current vacancies are reserved for persons who suffer from not less than 40% of relevant disabilities [OA, OL, BL, CP, LC, Dw, AAV, SLD, MD]. There are also 14 backlog vacancies for PWDs. In case of non-availability of suitable person with disabilities the carried forward reservation against 14 seats shall be filled by the persons other than a person with disabilities. Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidates belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog.
1. **Eligibility & Essential Qualification:** Approved MBBS/BDS degree from a Medical/Dental college recognized by NMC/DCI and Candidates should have provisional registration from DMC (Delhi Medical Council)/Delhi Dental Council, they can apply. Candidates who have completed internship during the period from 26.05.2020 to 25.05.2022 i.e last date of submission of application (02 years) will be considered. Those candidates who have already done one year Non-PG Junior Resident (irrespective of in parts or one go) in any Institute are not eligible.



2. **Pay Scale:** The scale of pay admissible to the Non-PG Junior Resident in the Level-10 (Rs. 56100/- to Rs. 177500/-) of the pay matrix + other allowances as admissible as per orders issued by the Government from time to time.

3. **Age Limit:** Not exceeding 30 years as on last date of submission of application (relaxable by 5 years of SC/ST candidates, 3 years for OBC Candidates. Age Relaxation of 10 years for Persons With Disability (15 years for SC/ST and 13 years for OBC Candidates).

4. **Reservation:** All Reservations will be considered in the above posts strictly in accordance with prescribed norms/rules as governed by Govt. of India.

i. SC/ST Candidates must bring community/caste certificate in the prescribed format of Govt. of India.

ii. Candidates seeking reservation as OBC candidates are required to submit certificate regarding OBC Status & Non Creamy Layer status as per the prescribed format issued by Govt. of India. The OBC certificate has been issued not earlier than one year from the last date of submission of application. Their Sub-Caste should match with the entries in Central Govt. List of OBC, failing which their candidature will not be considered under any of the applied reserved category and will be treated as UR.

iii. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority in the prescribed format Annexure-I. The certificate must be issued upto last date of submission of application. The candidates having certificate beyond last date of submission of application will not be considered for EWS candidate and their candidature will be treated as cancelled.

iv. For Persons with Disabilities the physical requirements are-

a. Medical / Surgical Department: S-can perform work by sitting, ST-can perform work by standing, W-can perform work by walking, SE-can perform work by seeing, H-can perform work by hearing/speaking, RW-can perform work by reading and writing.

b. Persons with disability to produce a certificate issued by a competent medical authority at the time of Scrutiny.

5. Other service conditions will be applicable as specified by the Govt. of India from time to time.

6. The candidates are advised to ensure that they fulfil the eligibility criteria as mentioned in the advertisement before applying for the post.

7. **Application Fee:**

For General, EWS & OBC candidates-	500/-
For SC/ST candidates	- 300/-
For PWD candidates	- No fee

Note: Application fee shall be paid through NTR portal bharatkosh.gov.in and the candidates should enclose the copy (2 copies) of the receipt along with their application. The detail regarding the same is mentioned in Annexure-II. The application fee will be non-refundable.

8. Incomplete application in any respect will not be considered. The candidate must attach one recent passport size photograph in application form.

9. **Mode of Selection:** Selection will be made on the basis of combined merit marks during written examination and interview. Counselling for Department allocation (For Medical JR) will be done on the basis of merit score in the written examination & interview for allotment of seats in various department and JR Dental will be handed over to Dental Department. However, the Institute reserves right to utilize the services of Non-PG Junior Residents in any Department or outside Institute in view of patient care or public interest. If there is a tie in the merit score, the rank will be decided on the basis of date of birth. The candidate with senior in age will be ranked higher. For candidates who have done MBBS from abroad, their score of NBE exam i.e FMGE will be taken into consideration.



10. The Question paper will have 50 MCQ with four responses (each question will be of 1 mark & ¼ mark will be deducted for wrong answer) and Interview has 50 marks.
11. **Result Publication:** Category wise Results along with waiting list will be available on hospital website and notice board.
12. **Tenure:** The selected candidates will be entitled to a maximum of 2 tenures of 06 months each.
13. **Notice period for Resignation:** >15 days of prior Notice period for resigning from the post with full applicable pay.
14. **Crucial date of determination of eligibility with reference to age, educational qualification and experience etc. will be the last date of submission of application.**
15. Candidate must attach self-attested certificates along with application form. The list of certificates to be attached is:-
 - a. Certificate in support of age (10th Certificate).
 - b. Certificate in support of educational qualification.
 - c. Experience Certificate, if any.
 - d. Registration Certificates of Delhi Medical Council/Delhi Dental Council (Original or acknowledgement slip)
 - e. Mark Sheets of MBBS/BDS Part I, II, & final year and MBBS/BDS degree.
 - f. Internship completion certificate.
 - g. Community/Caste/Disabilities Certificate where applicable
 - h. Proof of prize/medal/publications/conference attended/extracurricular activities etc.
 - i. Identity proof VIZ. Aadhar Card/PAN Card/Voter ID Card/Driving license/Passport.

Note:- The candidate must ensure that they are fulfilling eligibility to practice in Delhi and they must produce valid registration certificate from NMC/DCI/DMC/DDC before joining.

In view of complaints raised by the various Central Govt. Hospitals on discontinuation of ad-hoc appointment which lead to vacant resident posts and adversely affecting the smooth functioning of the Hospital. It is decided by the competent authority to follow old practice (ad-hoc appointment by conducting walk-in interview for vacant posts every month after inviting application through proper mechanism) in selection of Non-Academic JR/SR for Medical/Dental departments in Central Governments Hospitals until the finalization of new policy which is under consideration and policy circulated vide letter dated 14.03.2022 may be kept in abeyance. The selection should be done in a fair and transparent manner while following the reservation policy under intimation to the undersigned.
