#### **ENGAGEMENT OF DOCTORS ON CONTRACT BASIS AT WOU, MUMBAI**

Oil and Natural Gas Corporation Limited (ONGC), a "Maharatna" Public Sector Enterprise, and India's flagship energy major engaged in Exploration and Production of Oil and Gas in India and abroad, intends to engage Doctors on contract basis on the following posts at its locations in **Mumbai, Panvel, Nhava and Uran**:

- (i) Field Medical Officers (FMO)(Onshore/ Offshore posting (14 days On/Off))
- (ii) General Duty Medical Officers (GDMO)
- (iii) Medical Officer (Occupational Health)
- (iv) Visiting Specialists (Panvel)
- (v) Homeopathy (part-time)

The details of posts, qualifications required and the honorarium to be paid are mentioned in **table A** below. The period of contract shall be from the date of engagement till **30/06/2024**. The job is purely on contract basis and does not carry any liability on the part of ONGC to grant regular appointment at any stage.

- i. None of the posts are reserved for PWBD. However, the post of General Duty Medical Officer (GDMO), Medical Officer (Occupational Health), Homeopathy & Physician are identified suitable for PWD, so eligible PWD candidates may also apply. The disabilities for which the posts are identified are as follows:
  - a. GDMO & Homeopathy (OA, OL, BL, OAL, CP, LC, DW, AAV, SLD and Multiple Disabilities involving all preceding disabilities)
  - b. Physician (OA, OL, BL, OAL, LC, DW, AAV, SLD and Multiple Disabilities involving all preceding disabilities) and
  - c. Medical Officer (OH) (HH, OL, DW, AAV, ASD (M), SLD, MI and Multiple Disabilities involving all preceding disabilities except HH)

OA= One Arm, OL= One Leg, BL= Both Legs, OAL= One Arm & One Leg, CP= Cerebral Palsy LC= Leprosy Cured, DW= Dwarfism, AAV= Acid Attack Victims, SLD= Specific Learning Disability, HH= Hard of Hearing, ASD (M)= Autism Spectrom Disorder (M=Mild), MI= Mental Illness.

- ii. The Candidate must possess the essential prescribed qualifications as well as a valid registration with the concerned statutory authority (wherever applicable) **on or before the last date of application**. Experience is desirable for all posts.
- iii. Nomenclature of qualifications shall be as prescribed by UGC/ Medical Council of India/ National Medical Council(NMC).
- iv. Qualifications equivalent to the one prescribed in this advertisement will not be accepted. This includes any equivalent qualification acquired from a foreign university.
- v. Where the posts specified in this advertisement are not reserved for any category(ies), a reserved category candidate can also apply provided he fulfills the criteria specified for the post. However, he/she shall be treated at par with Unreserved category candidates.

- vi. Candidate's seeking reservation as SC/ST/OBC/EWS, shall have to produce a certificate in the prescribed proforma ONLY, meant for appointment to posts under the Government of India, from the designated authority indicating clearly the candidate's caste / community, the Act/Order under which the caste is recognised as SC/ST/OBC and the Village/Town the candidate is ordinarily a resident of. - vii. The OBC claim of a candidate will be determined in relation to the State (or part of the State) to which his/her father originally belongs. A candidate who has migrated from one State (or part of the State) to another should, therefore, produce an OBC certificate which should have been issued to him/her based on his/her father's OBC certificate from the State to which he (father) originally belongs.
- viii. Candidates seeking reservation under EWS will have to submit at the time of registration, an Income and Asset Certificate issued by a Competent Authority. The prescribed format and the Competent Authority for issuing the certificate have been given in Department of Personal & Training Office Memorandum No. 36039/1/2019 Estt (Res) dated 31/01/2019. Format of the certificate is also available on ONGC's website **www.ongcindia.com.**
- ix. Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancy for that particular recruitment year shall not be carried forward to the next recruitment year as backlog.
- x. Prescribed format of the certificate for SC/ST/OBC/EWS/PWD for employment in government undertaking is down-loadable from ONGC's website **www.ongcindia.com**.

## B. Age Limit

- a. The upper age limit for male candidates applying for Field Medical Officer (Offshore) is 60 years of age as on 30/06/2024.
- b. The upper age limit for female candidates applying for Field Medical Officer (Offshore) is 45 years. However, Female employees can be posted to offshore after attaining 45 years of age subject to medical clearance.
- c. For the remaining posts there is no maximum age limit for applying.

## C. How to Apply

- a) Candidates need to visit www.ongcindia.com to register on our Registration weblink. The registration site shall remain open from 31-05-2022 to 06-06-2022.
- b) Candidates need to attach the following documents in **pdf format** in their online form on the weblink and submit the same:
  - i. Scanned copy of Aadhar card

- ii. Class 10th Board Certificate containing Date of Birth (DOB). No other proof for determining Date of Birth shall be considered.
- iii. All semester MBBS/ B.H.M.S. marksheets.
- iv. M.B.B.S./ B.H.M.S./ M.S./ M.D. Degree. In case degree has not been issued then Provisional degree certificate
- v. Valid Registration Certificate with the statutory registration Council like MCI/ NMC etc. For the post of Homeopathy, registration with the Maharashtra Council of Homeopathy is Essential.
- vi. SC/ST/OBC Caste Certificate (in case of OBC candidate caste certificate / NCL certificate should be in central government format) and the Income & Asset Certificate in case of EWS candidates.
- c) In case of any difficulty in uploading their documents in the weblink, the candidates can mail the same on our e-mail id: <a href="mailto:recttongcmumbai@ongc.co.in">recttongcmumbai@ongc.co.in</a> before the last date of registration.
- d) In case of a face to face interview, candidates will be required to bring all testimonials in original along with a set of Self-Attested Photocopies of documents and report to DGM (HR)-I/C R&P as per date, time and venue intimated. Candidates will be intimated of the exact date and venue of the interview later.
- e) Shortlisted candidates shall be called for either a face to face interview or through video conferencing (to be decided later by ONGC) based on a preliminary verification of the documents submitted by the candidate. The candidates are therefore advised to submit complete documents and true and correct data in the weblink. In case of failure to submit complete information or complete set of documents, their candidature is liable to be rejected.
- f) In case of the interview being conducted through video conferencing, candidate will be advised the date and time of the interview through e-mail and through SMS. ONGC however does not take any responsibility of the mail being sent to a spam folder or the message not being delivered due to network failure.
- g) In case of video conferencing the following software shall be used for video communication:-MS Teams or Webex or Google Meet. For better user experience, candidates are advised to keep these apps downloaded. ONGC may add more apps for communication depending upon feasibility. Candidates will be informed of the detailed modalities for video conferencing subsequently.
- h) Shortlisting of Candidates for Interview of Contract Medical Officer Homeopathy: If large number of candidates apply for Post of Contract Medical Officer Homeopathy than ONGC may require to shortlist candidates for personal interview based on their marks in minimum essential qualification and inline higher qualifications. If situation arises than candidates will be shortlisted in the ratio of 1:10 (i.e. for 1 vacancy, 10 candidates will be called) on the sum total of weightages assigned to minimum essential qualification and inline higher qualifications as follows:

- 80 (eg. 60% marks in BHMS degree will have weightage of 48 marks)

**Bunching** – In case there are more than one candidate at minimum cut-off mark, all such candidates will be shortlisted for interview.

The percentage of marks has to be calculated as per institute / university rules. Candidates have to provide proof of calculation of percentage in case they are shortlisted for interview. Candidates are also advised to provide correct information in their online application.

- i) All communications with the candidate shall be through SMS / e-mail.
- j) Candidates may please ensure that they are fulfilling all the requisite criteria prior to appearing for personal interview, failing which, their candidature is liable to be rejected/cancelled.
- D. Selection Criteria: Following weightages shall be assigned to different parameters in the selection process:-

Qualification - 70 marks (60 marks for essential qualification & upto 10

marks for any relevant higher qualification)

Interview - 30 marks

The breakup of 10 marks for such higher qualification shall be considered as follows:

- a) Where a Bachelor's degree in the relevant field (M.B.B.S. or BHMS) is the minimum prescribed qualification, 5 marks shall be given to a Post-Graduation (PG) degree (e.g. MD/MS).
  - The qualification of PG in Community Health or Medicine/Preventive and Social Medicine/Occupational Health or Medicine will be eligible for 5 marks in the post Contract Medic – Occupational Health but the same shall not be eligible for additional 5 marks in the post of Contract Medics – General Duty / Field Duty.
  - The PG qualification in Anesthesiology/Dermatology, Venereology and Leprosy/Family Medicine/General Medicine/Pediatrics/Palliative Medicine/Pathology/Psychiatry/Radio-Diagnosis / Radiology/Tuberculosis and Respiratory diseases/Emergency and Critical care/Ear, Nose and Throat/General Surgery/Ophthalmology/Orthopedics/Obstetrics and Gynecology/Pulmonary and Sleep disorders/Traumatology & Surgery/Otorhinolaryngology will be eligible for additional 5 marks for the post of Contract Medic - General Duty / Field Duty / Occupational Health. Other qualifications such as PG in Biochemistry/Forensic Pharmacology/ Medicine/Microbiology/ Physical Medicine and Rehabilitation/Physiology will not be eligible for additional 5 marks.
  - The PG qualification in Homeopathy will be eligible for additional 5 marks for the post of Contract Medic – Homeopathy.
- b) Further additional 5 marks shall be given to a Post Master's qualification in the relevant field (e.g. M.Ch/ DM).
- c) However, where a Master's degree is the minimum essential qualification for example MD (Orthopedic) for the post of Orthopedic, minimum 60 marks may be given for the essential qualification. Additional 10 marks shall be given to a Post Master's qualification in the relevant field (e.g. M.Ch/ DM).

**D.** Qualifying marks in the interview shall be 18 marks for UR/OBC/EWS and 12 marks for SC/ST category.

#### E. Finalization of Merit List

- i. Candidates who qualify in the interview shall be empaneled in the Merit List.
- ii. Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the sum total of marks scored by the candidate in qualification and interview.
- iii. For posts other than Medical Officer-Occupational Health, in case of a tie in the total marks scored between two candidates, then the candidate who scores more marks in interview shall be considered senior. In case there too the marks are equal then the candidate who is older in age shall be considered senior for issue of offer of appointment.
- iv. For the post of Medical Officer-Occupational Health, in case of a tie in total marks between two candidates, one of whom has a training in occupational health/ public health or occupational medicine and the other doesn't, then preference shall be given to the candidate who has a training in occupational health/ public health or occupational medicine. In any other case, issue shall be dealt with as per para E.iii above.
- **F.** Appointment of selected candidates will be **subject to their passing the company's Medical Examination** as per standards laid down under ONGC Medical Examination of Employees Rules, 1996. Details of the rules are available on ONGC's Website at **www.ongcindia.com**.

#### I. General Instructions:

- i. Candidates can apply for one post only.
- ii. In case of candidates submitting multiple applications, the last application shall be considered as final for consideration of candidature.
- iii. Engagement is purely temporary, on contract basis, and can be terminated at any time by giving one month notice, by either side.
- iv. Engagement on contract would be subject to medical fitness.
- v. No claim for regular employment in ONGC, by virtue of this contractual engagement, shall be entertained at any stage.
- vi. Selected candidates will be paid consolidated monthly remuneration as mentioned above.
- vii. On successful completion of one year period an annual increase for Rs.1,500/- may be considered for Field Medical Officers (FMO), General Duty Medical Officers (GDMO) & Medical Officer (Occupational Health) engaged on full time contract basis. For part- time Homeopathy Doctors the annual increase will be Rs 400/-.
- viii. Field Medical Officers on contract are eligible for payment of two way air fare in economy/ premier- economy class in shortest route from family/ operating station to work centre. Doctors posted at Offshore are eligible for free boarding and lodging while on duty at Offshore. This is in addition to remuneration.
- ix. Twelve days casual leave will be granted in a calendar year on a pro-rata basis. One casual leave will be allowed for a month. Maternity leave will be granted as per Maternity Benefit Amendment Act to the female doctors subject to fulfillment of eligibility conditions laid down in the Act.
- x. Selected candidates shall be required to sign a contract agreement as per the terms and conditions of ONGC.
- xi. SC/ST/OBC/EWS reservation is provided as per government guidelines.
- xii. Contract tenure will commence from the date of joining.
- xiii. The contract shall end on expiry of the prescribed period and no separate notice shall be required to be given.
- xiv. Candidature/contract of candidate(s) submitting false certificates or suppression/ submission of incorrect information shall be liable for termination / disqualification / rejection at any stage.
- xv. Only Indian nationals need to apply.
- xvi. No TA/DA shall be paid for attending the interview.
- xvii. Interested candidates fulfilling the above conditions will have to appear for an interview either face to face or through video conferencing (to be decided by ONGC). Candidates shall be intimated the date and time of interview through SMS/ E-mail.

- Family floater cover of Rs.7.5 lakhs for indoor treatment in respect of self, spouse and two immediate dependents i.e. children and/ or parents.
