Defence Electronics Research Laboratory(DLRL), Hyderabad is a premier Laboratory under Department of DRDO, Ministry of Defence. The Laboratory invites applications from young and meritorious Indian National for Engagement of Trade(ITI) Apprentices. Selection will be made on the basis of Academic Merit/ Personal Interaction as required.

- (1) For the above mentioned apprentice, reservation for SC/ST/OBC/PWD/EWS categories will be applicable as per provision of Apprentice Act, 1961 and rules made there under.
- 2) The number of apprentice mentioned above are only indicative and may change at a later stage depending on the final assessment of eligible applications received.

## **Terms and Conditions for selection of Apprentices :-**

1. Candidates for Trade Apprentice should have registered at [www.apprenticeshipindia.org](http://www.apprenticeshipindia.org).
2. Applications registered on-line through [www.apprenticeshipindia.org](http://www.apprenticeshipindia.org) only will be accepted
3. Those candidates who have completed the qualifying examination(ITI) as regular candidates are only eligible to apply.
4. Candidates who have passed the qualifying examination(ITI) in the year 2019, 2020,2021 are ONLY eligible to apply for the apprenticeship.
5. The tenure of the Apprenticeship for above trades would be ONE YEAR commencing from execution of contract of apprenticeship.
6. A physical fitness certificate from a civil Assistant Surgeon should be produced by the selected candidate at the time of joining.
7. DLRL being a highly protected establishment, selected candidates have to submit the following certificates at the time of joining;
  - a) Police Verification Certificate from their Local Police Station. And
  - b) Conduct/ Character Certificates from head of previous educational Institute OR from a Group A Gazetted Officer.
8. Verification of credential shall be done and in case of any deviation from or non-conformity with the desired qualifications, candidates shall be summarily rejected.
9. Suppression of facts will also lead to disqualification at any stage of the selection process or during the training period.
10. Candidates who have already undergone or who are currently undergoing Apprenticeship under Apprenticeship Act 1961 are not eligible to apply.
11. No TA/DA will be paid to the applicants called for at any stage of the selection process.
12. The apprentices will NOT be provided any hostel accommodation/quarter/transport by the establishment at any stage of the selection process, and also during the training period. Also no allowances will be admissible except the consolidated stipend.
13. Candidates selected for training will not be allowed to withdraw from training except for reasons which are beyond their control. Before commencement of the training, the candidates will have to execute a Contract of Apprenticeship. Those who absent themselves are liable to refund the whole cost of their training as well as the amount received as stipend as determined by the Central Apprenticeship Advisor.
14. Offer of Apprenticeship does not confer on the candidates, any right for absorption in DRDO.
15. DLRL reserves the right to withdraw/ cancel the advertisement if circumstances so warrant without assigning any reason thereof.
16. It is mandatory to provide percentage of mark secured at essential qualification level during filling up of online application.
17. In case of any dispute, the legal jurisdiction will be at Hyderabad.

## **How to Apply:**

1. Online application process will start on RAC website (<https://rac.gov.in>) from the date of advertisement in Employment News and closes on 21<sup>st</sup> day at 12 PM.
2. Interested candidates with qualifications as above are invited to apply online through website <https://rac.gov.in> with uploading the self attested copies of relevant certificates and testimonials in support of age, qualification and caste.
3. All information regarding Written Test/Interview, Call letters, etc. if required shall be provided through website/candidate's E-mail only. No hardcopy mailing of Written Test/Interview Call letters shall be done by the DLRL. Responsibility of receiving, downloading and printing of Admit Card / Call Letter shall be that of the candidate.
4. Candidates should keep a copy of the online application for their record.
5. Applicants are advised to keep a watch on the above website for any updates / changes.

**Selection Criteria for Apprentice Trainee:**

1. Selection will be made on the basis of Percentage of mark secured by candidates at essential qualification level. **OR**
  2. Personal Interview through Video Conferencing (Virtual) mode for shortlisted candidates only.
