1. Application :-

Online application forms from the eligible candidates are invited through the link provided by the Examination Section within prescribed time. The eligible candidates desiring to appear in Examination shall submit their online application forms on or before **18.10.2022**. The list of eligible candidates has already been ported on the website alongwith this Advertisement.

The application(s) submitted after due date shall be rejected out-rightly. The candidate (s) who has/have not applied for the Exam shall be treated as “unwilling” to appear in the Exam.

Procedure for submitting Online Application Form :-

A link for filling the online application form is provided to all eligible candidates on the website of High Court of Madhya Pradesh (www.mphc.gov.in). By clicking on the provided link the application form will get open, after filling the Application Form, candidate have to click on “browse” button to upload recent Color Photo and Signature (only in *jpeg* format). Thereafter, candidates are advised to check the preview of Application Form, if all entries are correct then click on “submit” button otherwise click on “reset” button to modify the entry.

- Note:-** 1. Candidates are required to read all information carefully before submitting the Application Form as there is no provision for correction of the same after final submission.
2. Candidates are advised to keep a printout of the finally submitted application form.

2. Disqualifications :-

In any of the following cases, the Judicial Officer/candidate for aforesaid examination shall be disqualified and/or Departmental action for misconduct may be initiated against him:-

- (i) If he or she takes or attempts to take any favour in any form at any stage of examination, or
- (ii) Impersonation by or for the candidate, or
- (iii) Making or submitting any forged document in support of his or her candidature, or
- (iv) If he or she conceals any material information or provides any false information at any stage of selection process, or
- (v) If he or she uses or attempts to use, improper or illegal means, either for purpose of being permitted to appear in examination or at any stage of examination in examination room/hall, or
- (vi) If he or she, during written examination harasses or threatens or causes physical injury to or misbehaves with, any Officer or employee engaged there, or
- (vii) If he or she, disobeys any directions relating to examination including oral directions by the invigilator or observer or any other Officer or employee engaged in conduction of examination.

Moreover, Canvassing in any form will also be tantamount to disqualification. Similarly, any attempt on the part of a candidate to enlist support for his candidature or selection/appointment, through persons of influence or officers of Government/High Court will also disqualify him for appointment.

3. Admit cards -

Admit Cards shall be generated at about 05 days prior to the date of examination by High Court of Madhya Pradesh on its website (www.mphc.gov.in). Candidate(s) shall have to download and take print-out of their respective Admit Card(s). Admit Card shall be issued only to those candidates / Civil Judges (Senior Division) whose applications are received by High Court examination cell within prescribed time limit.

4. Date, Time & Venue of Examination –

Written Examination will be held on **20.11.2022 (Sunday)** at 11:00 am to 02:00 pm (03 hours), at High Court Campus, at Jabalpur. Candidates are advised to reach examination centre atleast 30 minutes before the examination time.

6. Objections & Finalization of Model Answers of 1st Question Paper:-

After completion of exam, the proposed model answers/keys intended to be used to generate result of OMR sheets, shall be uploaded/published on the website of the High Court of Madhya Pradesh for the purpose that if any candidate wishes to make any objection/clarification etc. regarding any

proposed modal answer, he /she may submit their respective objection(s) in writing and duly signed by mentioning his/her name along-with self attested photo copies of source document(s) / proof, on the basis of which he/she has raised objection/clarification *etc.*, to the Principal Registrar (Exam), High Court of M.P., Jabalpur, through E-mail (pregexamhcjbp@mp.gov.in) within 03 days from the date of uploading/ publication of the proposed Model Answers/ Keys.

If no objection is received within prescribed time then proposed answers shall be treated as final for purpose of generation of result. After declaration of result, no representation regarding any objection/clarification to model Answers / questions, shall be entertained for any ground(s) and shall stand rejected without assigning any reason.

7. Passing Marks-

Passing marks shall be Minimum 45% (aggregate of both papers) in written suitability examination.

8. Final Result –

The Final List of Successful & Unsuccessful candidates along-with marks obtained in both papers shall be ported on the Website of High Court of Madhya Pradesh. There is no provision of revaluation of answer-books and any application from any candidate for revaluation, if received, shall stand rejected without assigning any reason.

9. Corrigendum :-


At any time after the recruitment process has started, if any Clarification, Modification *etc.* is required to be made on the part of High Court then it may be done by porting a corrigendum on the official website of High Court of MP. Porting of corrigendum on official website shall be deemed as sufficient notice to all candidates/ aspirants and no objection shall be entertained on the ground that candidate was having no information of such corrigendum.

11. R.T.I. :-

If any candidate applies under RTI and if rules permit then the desired information shall be made available, only to the candidate concerned, by the High Court of MP, subject to payment of prescribed fees only after declaration of Final Result & before expiry of a period of elimination of records.

12. Elimination/disposal of Used Examination Materials :-

The used Examination material shall be eliminated after expiry of One year from the date of declaration/publication of Final Select List.
