3 (three) posts reserved for Persons with Benchmark Disabilities in the non surgical departments as per Government of India policy:

**Criteria for Persons with Benchmark Disabilities:** One per cent each reserved for persons with benchmark disabilities under clauses (a), (b) and (c) and one per cent for persons with benchmark disabilities under clauses (d) and (e) namely:-

- Blindness and low vision;
- Deaf and hard of hearing;

- (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- (d) Autism, intellectual disability, specific learning disability and mental illness;
- (e) Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the posts identified for each disabilities.

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Government Hospital/Institutions and countersigned by Medical Superintendent /CMO/Head of Hospital/Institution.

The Medical Board issuing certificate shall conform to guidelines of Ministry of Social Welfare and Empowerment (Govt.of India)

***Candidates from General Category will also be considered for adhoc appointment against vacant post of reserved category (marked asterisk\*), if reserved category candidates would not be available (In respect of department of General Surgery, 2 posts will be considered for adhoc appointment against OBC post).***

The numbers of vacant posts indicated above are **inclusive of backlog vacancies**.

As per guidelines EWS posts are not carried forward/or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for the post subject to the condition that they will be considered for the post as UR candidate only if EWS category seat is otherwise not filled up.

**A. Essential Qualification for the post of Senior Resident Doctors:**

- i. Postgraduate degree or diploma in respective subject recognized by MCI after obtaining a medical qualification included in the Schedule – I & II of the 3<sup>rd</sup> Schedule of Indian Medical Council Act 1956 (persons possessing qualifications included in the part – II of the 3<sup>rd</sup> schedule should also fulfill the conditions specified in section 13 (B) of the Act).
- ii. Satisfactory completion of the compulsory internship/housemanship in a recognized hospital.
- iii. Candidate must be registered with the State Medical Council/Medical Council of India.

**B. Desirable:** Candidates having experience in the respective discipline/subject will be preferred.

**Scale of Pay:** Level 11 of Pay Matrix with entry pay of ₹.67700/- per month plus NPA and other allowances as admissible under the Central Govt. Rules in identical posts.

**Age limit** - 45 years

**Eligible candidates are requested to present themselves for registration at 09:30 a.m to 10:45 a.m on 14<sup>th</sup> , 15<sup>th</sup> , 16<sup>th</sup> & 17<sup>th</sup> February 2023 for the posts of SRDs in the Conference Hall, NEIGRIHMS Guest House, Permanent Campus, Mawdiangdiang. They will have to fill in their particulars in the prescribed application format and enclosed the following relevant documents duly attested:-**

- i. One recent passport size photo
- ii. Certificate of Date of Birth (10<sup>th</sup> certificate)
- iii. Certificate of SC/ST/Latest OBC (Non-Creamy Layer) certificate from the competent authority if applicable.
- iv. MBBS passed Certificate
- v. MBBS Marksheets
- vi. MBBS Attempt certificate
- vii. MBBS Internship Completion Certificate
- viii. MD/MS/DNB/Diploma passed certificate
- ix. Medical Registration Certificate for MBBS/MD/MS/DNB/Diploma
- x. NOC from the present employer (if employed)

- xi. Experience Certificate (if applicable)
- xii. Residence Certificate issued by competent authority or Aadhar card or voter ID and Passport
- xiii. Character Certificate

**General Information:**

1. Reservation for the above posts and age relaxation will be provided as per Govt. of India Norms. Age is relaxable upto 5 (five) years for SC/ST and 3(three) years for OBC (Non-creamy layers) candidates in respect of vacancies reserved for them. Age relaxation for physically handicapped candidates will be provided as per Govt. of India Norms.
2. Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt.of India policy Office Memorandum No.36039/1/2019-Estt (Res) dated 19<sup>th</sup> January, 2019 and 31<sup>st</sup> January, 2019.  
*EWSs Candidates will attach certificate issued by the competent authority in the form prescribed as per **Annexure-II**.*
3. If employed under the State or Central Govt. or PSU/Autonomous body, applicants are required to produce NOC from competent authority, failing which they will not be allowed to appear for interview under any circumstances.
4. Candidate who have already worked in State or Central Govt. or PSU/Autonomous body and have resigned/left their jobs are required to produce the Relieving Order, failing which they will not be allowed to appear for interview under any circumstances.
5. Canvassing in any form will disqualify candidate.
6. Crucial date for determination of eligibility with regard to age, educational qualification and experience etc. **will be the date; the candidates appear in the interview.**
7. Candidates who does not fulfill any one of the above conditions, will not be allowed to appear in the interview. They are to ensure that they fulfill the eligibility criteria before coming to appear the walk in interview.
8. Candidates who have been sponsored by the Govt. of Meghalaya for MBBS/MD/MS programme are required to produce NOC from the Govt. of Meghalaya prior to joining the post, if selected.
9. Candidates who have been sponsored by the respective state governments for pursuing MBBS course and are required to undergo compulsory rural posting, if any. Such candidates will have to submit the certificate of completion of rural posting. They will be allowed provisionally to appear for interview subject to compliance of mandatory requirement.
10. Appropriate accommodation as per availability will be provided.
11. No travelling allowance will be paid by this office for attending the interview.
12. Institute reserves the right to reject or accept any candidature without assigning any reason thereof.
13. The decision of the Institute as to eligibility or otherwise of a candidate will be final.
