1. QUALIFICATION (AS ON DATE: 10.03.2023)

(i) The candidates should have passed MBBS (including completion of Internship) from the MCI/NMC recognized Institute.

(ii) NMC/MCI/State Registration is mandatory to be produced before joining, if selected

2. AGE LIMIT (AS ON 10.03.2023):

For eligibility to apply for these posts, upper age limit will be 37 years. Age limit relaxation for SC/ST candidate up to a maximum period of 5 years and for OBC candidate up to a maximum period of 3 years.

In the case of Orthopedic/ Physical handicapped (OPH) candidates, age limit is relaxable upto maximum period of 05 years for General Category, 08 years for OBC category and 10 years for SC/ST candidates.

3. <u>APPLICATION FEES & MODE OF PAYMENT:</u>

UR, EWS & OBC (NCL) Candidate(s)	: Rs. 1200/- + transaction charges as applicable.
SC & ST Candidate(s)	: Rs. 500/- + transaction charges as applicable.
PwBD Candidate(s)	: Exempted for payment of application fee.

Application fee is required to be remitted online only. Any other instrument of payment is not acceptable. Also make sure to get the confirmation of the successful remittance by your bank and retain the proof of the same which may be required at the time of document verification. The application fee is non-refundable.

4. <u>APPLICATION PROCESS:</u>

Candidates, who are fulfilling the eligibility criteria may fill the application form which will be available at <u>www.aiimspatna.edu.in</u>. After final submission of form, candidates have to take a print of the same, which along with following documents (**original and one set of self-attested copies**) needs to be produced at the time of interview:-

- > Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
- MBBS Provisional/Degree Certificate
- Internship Completion Certificate
- > NMC/State Registration Certificate
- Category/PwBD Certificate (If seat is claimed in reserved category)
- > Any other relevant certificate of experience

5. <u>RESERVATION:</u>

Reservation for SC/ST/OBC/EWS/PwBD shall be applicable as per Govt. of India rules.

OBC Candidate's eligibility will be based on the caste(s) borne in the Central list of Government of India. OBC Certificate should not be older than one year as on the last date of application. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should be matched with the entries in Central List of OBC, failing which their candidature will not be considered under OBC reserved category post(s).

For SC/ST Candidates - Certificate should be issued by rank of Tehsildar or above in standard format of Central Government.

➢ PwBD Candidates – The disability certificate should be signed by duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent or equivalent. The constitution of the Medical Board will be of one consultant each from disciplines of Orthopedics, Physical Medicine & Rehabilitation and Surgery.

> RESERVATION FOR ECONOMICALLY WEAKER SECTION (EWS) :

The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuinity of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the date of interview, except in cases where date is fixed otherwise. Therefore, a valid EWS certificate will be the one which has been issued by the competent authority, as prescribed by the GOI/DOPT. Candidates who fail to produce valid EWS certificate will not be considered for reservation under this category. They will however, be considered for UR category. Therefore, EWS candidate must ensure that they have a valid EWS certificate on the date of interview. The EWS certificate must be valid for financial year 2022-2023 and issued on or after 01.04.2022 & on or before the last date of submission of application based on income of year 2021-2022.





Note : As per EWS guidelines, if vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and these vacancies may be filled up as unreserved vacancies at the discretion of the selection committee.

(a) For filling up of online application, candidates must have the following pre-requisites ready:

- > Valid E-mail ID and Mobile Number.
- Scanned recent Passport size photograph of candidate (in JPG format).
- Scanned signature of the candidate (in JPG format).
- > Online payment detail of the required application fee.
- Aadhar Card.

Internship Completion Certificate, Caste Certificate/Pwbd Certificate, (If seat is claimed in reserved category), Any other relevant Certificate of Experience: Before applying online application form, a candidate will be required to have a scanned (digital) image of the above mentioned certificates/documents as per the specifications given below:

i. <u>Photograph (in JPG format):</u>

- > Photograph must be a recent of passport size.
- > The picture should be in colour, against a light-coloured, preferably white, background.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200 x 230 pixels (preferred)
- Size of file should be between 80 kb-100 kb
- > Ensure that the size of the scanned image is <u>not more than 100 KB</u>.

ii. <u>Signature (in JPG format):</u>

- > The applicant has to sign on white paper with Black ink pen.
- Dimensions 140 x 60 pixels (preferred)
- Size of file should be between 50 kb 80 kb
- > Ensure that the size of the scanned image is <u>not more than 80 KB</u>.

iii. <u>Date of Birth/SSC/HSSC Pass certificate (mentioning Date of Birth) (in PDF format):</u>

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

iv. <u>MBBS Provisional/Degree Certificate (in PDF format)</u>:

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

v. MBBS Internship Completion Certificate (in PDF format):

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

vi. <u>State or NMC/DCI Registration Certificate (in PDF format)</u>:

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

vii. <u>Caste/EWS/PwBD Certificate, if applicable (in PDF format):</u>

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

viii. Experience Certificate, if any (in PDF format):

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

ix. NOC, if applicable (in PDF format):

> Ensure that the size of the scanned image is <u>not more than 1 MB</u>.

(c) While applying online, in the preview of the form, the candidate's Photo and Signature must be clearly visible to candidate, if photo/signature image is small in size or not visible in preview on website, then it means that the photo/signature is not as per the prescribed format and your application will be rejected. So, be careful while uploading your photo and signature.

(d) Applicants must fill all the fields carefully since after submission of online application, request

for change in any information at any later stage will not be considered.

(e) Candidate may access the online application portal by clicking on the link mentioned in the website (i.e. <u>www.aiimspatna.edu.in</u>).

(f) After completing the registration part candidate will receive the user ID and password through E-mail on the registered email address. The same ID and Password shall be displayed on the logged screen. Candidates are requested to note down the User ID and password. Candidates are also advised to take a print of the Registered Application Form for their records and future reference.

(g) The candidates already registered shall click on existing user link and fill the correct user ID and Password for continuing the form filling process. In case of incorrect User ID/Password click on the 'forgot password' link.

(h) The candidates are requested to fill the correct details regarding name/age/sex/caste/address/educational qualification and other relevant fields mentioned in the application portal. Candidates are advised to upload the relevant documents/photographs in the desired format only.

(i) Once the details are correctly filled the candidate may proceed for the fee payment.

(j) Once a candidate clicks on SUBMIT button, a page containing some important instructions for payment, a Payment Reference Number and a Link to make payment of Application Fee will open. Candidates may please note that unless they make the payment of Application Fee, their application will be treated as INCOMPLETE. Candidates who want to pay at later stage can use this Payment Reference Number for re-login and making the payment in order to complete his/her Registration.

(k) Online payment of fee: Once a candidate clicks on button for making the payment, they will be redirect to the Payment gateway site. There are various options available for payment viz. Internet Banking (major banks) & Debit/Credit Cards. Additional charges viz. bank charges, service tax etc. incurred while making online payment of application fees will be borne by the candidate. After making the successful Payment they will immediately be redirected to (www.aiimspatna.edu.in) for generation of Registered Application Form. Candidates are advised to take a print of the Registered Application Form for their records and future reference. Thus, the process for Registration of candidates who have to pay Application Fee gets completed. The Registration number along with Date of Birth can also be used for downloading the Admit Card prior to the date of examination which shall also be notified in the designated website i.e. www.aiimspatna.edu.in

(I) Once form is submitted, there shall be no provision for making changes in the application form.

(m) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

9. <u>SELECTION PROCESS:</u>

- a) Written test (MCQ based) will be held for selection to the advertised posts of Junior Residents.
- b) Total Number of questions will be 80, carrying one marks each. There will be no negative marking.
- c) Written test will be held on **24.03.2023 at AIIMS PATNA only.** Result of the written examination will be declared on same day on AIIMS, Patna website (www.aiimspatna.edu.in).





d) Qualifying marks for written test will be as under: UR: 50 % OBC-NCL/EWS: 45 % SC/ST: 40 %

- e) The successful candidates will be called for the personal interview to be conducted on 25.03.2023. Total marks of interview will be of 20 Marks.
- f) Final Selection list will be declared on the combined marks of written and Interview marks.
- g) While every effort will be made to intimate the candidates regarding Exam/Interview schedule at the earliest, the responsibility lies with the candidate to check for the same on the institute website. All Candidates must provide phone numbers and E-mail for faster communication.
- h) Qualification/Experience will be counted **as on 10.03.2023**.
- i) The final result will be displayed on the website i.e. <u>(www.aiimspatna.edu.in)</u>.

10. <u>METHOD OF RESOLVING TIES:</u>

All Tie cases (more than one candidate having same marks) will be resolved by age of the candidate. Older candidate (earlier date of birth) will be ranked above younger candidate.

11. <u>REASONS FOR REJECTION/CANCELLATION OF APPLICATION:</u>

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/ REJECTED SUMMARILY OR AT ANY STAGE OF THE RECRUITMENT PROCESS IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- i. Applications being incomplete.
- ii. Any variation in the Signatures. All the SIGNATUREs in FULL (NOT IN SHORT) done on the Print out of the Application Form and also on other Documents must be the same.
- iii. Scanned copy of photograph and signature uploaded are not as per specification given and/or blur or distorted or not clear.
- iv. Non-payment of Examination Fees or non-receipt of fee through online mode, if not otherwise exempted.
- v. Fee not paid as per instructions.
- vi. Over aged candidates.
- vii. Failure to bring (in original) all relevant Certificates/Documents issued by the competent authority, along with self-attested legible copies in support of the information given in their Application Forms about their Educational Qualifications; Experiences; Percentage of Marks obtained; Proof of Age; Proof of Category [SC/ST/OBC/EWS/PwBD] and the print out of Application Form at the time of verification of document.
- viii.Not having the requisite Educational Qualification/ Category Status as on the closing/cut-off date.
- ix. Incorrect information or misrepresentation or suppression of material facts.
- x. For carrying mobile phones / accessories / banned items in the Examination premises/Hall.
- xi. Any other irregularity.

12. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

(A) Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form. Candidates are also warned that they should in no case attempt to alter or otherwise tamper with any entry in a document or the attested certified copy submitted by them nor should they





submit a tampered/fabricated document. If there is any inaccuracy or any discrepancy, an explanation regarding this discrepancy should be submitted.

- (B) Without prejudice to criminal action/debarment up to 3 years from examinations conducted by AIIMS, Patna wherever necessary, candidature will be summarily cancelled at any stage of the admission in respect of candidates found to have indulged in any of the following activities:
 - i. In possession of mobile phone and/or accessories and other electronic gadgets within the premises of the examination centers, whether in use or in switched off mode.
 - ii. Involved in malpractices.
 - iii. Using unfair means in the examination hall.
 - iv. Obtaining support for his / her candidature by any means.
 - v. Impersonate/ procuring impersonation by any person.
 - vi. Submitting fabricated documents or documents which have been tampered with.
 - vii. Making statements which are incorrect or false or suppressing material information.
 - viii. Resorting to any other irregular or improper means in connection with his/her candidature for the examination.
 - ix. Misbehaving in any other manner in the examination hall with the Supervisor, Invigilator or representative of AIIMS, Patna.
 - x. Intimidating or causing bodily harm to the staff employed by AIIMS, Patna for the conduct of examination.

13. OTHER IMPORTANT POINTS:

- i. Please fill the Online Application carefully. It may not be possible to make changes after payment of online fee. Applicants may note that further correspondence will NOT be entertained in this regard.
- ii. Any Amendment/Rectification/Change/Editing is NOT allowed in Name, Category and PWBD status after submitting the application fee through Debit/Credit Card/Net Banking and images once uploaded cannot be changed later. Any change in address, mobile no. and email ID should be intimated to this office immediately.
- iii. **Tenure** :- The tenure for the posts of Junior Residents shall be as per Residency Scheme laid down by the Ministry of Health & Family Welfare, Government of India. The maximum duration will be extendable upto one year as per Residency Scheme (Adhoc/Regular), including the duration of residency already rendered by the applicant in any hospital of govt./ public sector undertaking / autonomous bodies funded by the govt. prior to this appointment, if any.
- iv. **Expiry of Appointment** :- The appointment is for 89 days and can be terminated at any time by the Institute by giving fifteen days notice or salary in lieu thereof. The employee can also leave the institute by giving fifteen days notice or salary in lieu thereof. The appointment shall be terminated immediately on the basis of unsatisfactory work or continued absence or on disciplinary grounds. If termination of service is made on the basis of unsatisfactory work or due to continued absence of the appointee or on the disciplinary grounds, then he/she will not be entitled for any salary in lieu of notice period.
- v. **Salary :** The appointee will be entitled to salary as per residency scheme of Govt of India, as amended by the Government from time to time.
- vi. Leave : 2.5 days per month.
- vii. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- viii. The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
- ix. The appointment is whole time and private practice of any kind is prohibited. He/She will have to work in shifts and can be posted at any place in the Institute.





x. He/ She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.

- xi. No travelling or other allowances will be paid to the candidate for interview/ joining the post.
- xii. The candidate should not have been convicted by any Court of Law.
- xiii. Canvasing in any form will render the candidate disqualified for the post.
- xiv. - xviii. There is no provision for re-checking/re-evaluation of the answer sheets and no query in this regard will been entertained.
- xix. The decision of the Executive Director of the Institute shall be final in the matter of selection of candidates for applying for Junior Resident (Non-Academic) and no appeal will be entertained in this regard.
- xx. The selection of candidates for the post of Junior Resident (Non-Academic) will be subject to medical fitness. No selected candidate will be permitted to join the institute unless declared medically fit by the Medical Board appointed by the Institute. The decision of the Medical Board shall be final.
- xxi. Candidates have to join within 15 days from the date of declaration of result. No extension will be allowed any circumstances.
- xxii. The rules are subject to change in accordance with the decision of the Institute to be taken from time to time.
