### DETAILS, TERMS & CONDITIONS OF SENIOR RESIDENTS UNDER 03 YEARS SENIOR RESIDENCY PROGRAMME:

Note: Reservation benefit shall be applicable to Bihar State Domicile candidate only and the applicant from out-side the State of Bihar will not be entitled for the reservation. Physically-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar

Rs.67700/- during 1<sup>st</sup> year, Rs. 69700/- 2<sup>nd</sup> year and Rs. 71800/- 3<sup>rd</sup> year + NPA + usual allowances as admissible for Senior Resident in this Institute.

**Upper Age Limit: 45** (Forty Five) years as on **01-05-2023** (Relaxation as per State Govt. Rule, i.e., 05 years for SC/ST, 03 years of EBC/BC and 03 years for all categories of Female Candidate).

#### **Essential Qualification & Experience for Senior Residents:**

- 1. A Medical qualification as included in schedule I & II of NMC Act.**
- 2. N.M.C. recognized P.G. qualification of MD/MS in specialization concerned or allied Surgical/ Medical specialty.**
  - A. A postgraduate Medical Degree viz. MD in Emergency Medicine, from a recognized University/Institute, For the post of Medical Emergency in case of non-availability of candidate with Emergency Medicine qualification, candidates with M.D. Medicine will be considered for these posts, and interview will be held separately for this post. For which separate application is required to be submitted with separate fee.
- 3. The candidate must be registered with Central/State Medical Council.**

The qualification prescribed is minimum requirement and the same does not automatically make the candidates eligible for interview. Based on bio-data and interview, the Selection Committee of the Institute will select the candidate/s for appointment. Candidate/s, have to produce all original relevant certificates, in proof of details furnished in their application at the time of interview / document verification.

#### GENERAL INSTRUCTIONS

1. Application form can be downloaded from our website [www.igims.org](http://www.igims.org). The cost of application form:- **Rs.1000/-** (Rupees One Thousand) for UR/EWS/BC candidate and **Rs. 250/-** (Rupees Two Hundred & Fifty) for SC/ST/EBC candidate (Non-Refundable) payable to The Director, IGIMS, at Patna, in the form of Demand Draft.
2. Candidates employed in Government/Semi Government Department or any other employer must submit their application along-with "**No Objection Certificate**" issued by the employer, at the time of interview/document verification, otherwise, they will not be considered for interview. In case of not in employment, candidate must submit in writing that they are neither employed in any organization nor doing any course anywhere.
3. **Reservation:** Reservation point and relaxation in upper age limit will be applicable as per rule of Govt. of Bihar. Reservation benefit shall be applicable to Bihar State Domicile candidate only and the applicant from out-side the State of Bihar will not be entitled for the reservation. Physically-Handicapped candidate will be given the benefit of reservation and relaxation as per rule of Govt. of Bihar. Person working in Govt. Institution shall be given relaxation as per rule.
  1. The reservation for BC/EBC/SC/ST/EWS & Female candidates is as per Bihar Govt. rules and 4 % for PWD including OPH candidates (on horizontal basis.)
  2. For BC/EBC candidate: Candidates must attach certificate valid for the posts under prescribed by the Government of Bihar which mentions that the candidate does not belong to Creamy Layer (**form -X**). Date of issue of Certificate should not earlier than 01 years from the date of interview.
  3. EWS certificate should have been issued after **01-01-2023** till date of interview.
  4. FOR SC, ST, EWS & PWD – certificate should be issued by authorities prescribed by Govt. of Bihar.

#### **NOTE:**

In-case of unavailability of eligible FEMALE candidate (Where applicable) MALE candidate may be considered & In-case of unavailability of eligible EWS candidate (Where applicable) Un-reserved candidate for respective Department, may be considered.

4. **Number of vacancy, in each department may increase or decrease.**
5. In addition to Pay + NPA, other allowances will be admissible as per rule.
6. These posts are non-practicing & Private Practice of any kind, direct or in-direct including laboratory, is strictly prohibited and if found indulging in such private-practice, appointment of candidate shall be terminated & suitable penalty will be imposed.

7. Selected candidate/s have to submit a LEGAL BOND that they will deposit amount equivalent to the amount paid to them at the rate of one month's emoluments for every year of Sr. Residency programme not completed, on quitting/resigning the Senior Residency programme, mid-way.
8. Stay in campus is compulsory, if accommodation is provided. If not provided, HRA's admissible as per rule.
9. Separate application with separate fee duly completed in all respect for each department/post should be submitted.
10. The Selection Committee's panel will be valid for 01 year.
11. The Director of the Institute reserves the right to reject/accept any or all the applications without assigning any reason and cancel the advertisement.
12. Canvassing in any form will be a disqualification.
13. No TA/DA is admissible for attending the interview & joining the post if selected.
14. A declaration that whether they have filled-up Declaration form and appeared before the N.M.C. Team for the year 2023-24, for any Medical College or not, should be submitted with the application.
15. Mere selection by the Selection Committee does not give right of appointment to the candidate. The Institute reserves the right of appointment of the candidate/s recommended by the Selection Committee.


