ARMAMENT RESEARCH AND DEVELOPMENT ESTABLISHMENT (ARDE) invites Online Application from eligible ITI holders, for undergoing Apprenticeship training under the Apprenticeship (Amendment) Act 1961 and amended from time to time.

Candidates seeking apprenticeship training should register through the following web portals: www.apprenticeshipindia.gov.in. The advertisement for portal entry for the below mentioned apprenticeship will be open from **20th – 30th May 2023**.

A. Category – 13 Trade (ITI) Apprentices :

First Class ITI (full time course) in the respective discipline with 60% marks from a Indian Institute recognised by State/ Government of India. (relaxed to 50% marks for SC/ST/PwD candidates and relaxation applicable for reserved posts only)

AGE: 18-27 years as on 20.05.2023. Relaxation to reserved category candidates as per guidelines in this regard.

- 1. RESERVATION OF VACANCIES :** Guidelines under the Apprentices Act on reservation for SC/ST/OBC will be followed. Candidates claiming reservation under SC/ST/OBC/PwD shall provide certificate as per the standard format prescribed by the Government, failing which their claim for reservation will not be considered and they will be treated as 'General' category only. Candidates claiming reservation under OBC category should produce OBC Certificate (non-creamy layer) as per Govt. prescribed format from certificate issuing authority/ Tahsildar. Necessary certificate needs to be produced at the time of interview.
- 2. DURATION OF TRAINING :** The duration of Apprenticeship training will be for a period of 12 months as per Apprentices Act 1961. Examination and Completion Certificate will be issued to pass candidates after 12 months from date of execution of contract.
- 3. PREVIOUS TRAINING EXPERIENCE :** Candidates who have already undergone or are currently undergoing apprenticeship under Apprenticeship Act 1961, and/or already having one year of experience **are not eligible** to apply.
- 4. SELECTION PROCEDURE :**
 - 4.1** Selection will be based on the marks obtained in the respective discipline qualifying examination. The final merit list would be prepared according to categories General/SC/ST/OBC/PwD on the basis of marks obtained by the candidates in written examination. Written examination will be conducted during 1st week of June 2023 depending on the trade applied. Post screening of the online application, shortlisted candidates will be intimated to appear for written examination.
 - 4.2** The offline examination will consist of general reasoning, English, Maths & subject related questions.
 - 4.3** Engagement for apprenticeship training will be subject to the selected candidates clearing the medical examination and Police Verification.
 - 4.4** Furnishing of incomplete/incorrect/misleading/illegible documents, information or any other invalid data/inputs may result in the rejection of application and appeal for reconsideration will not be entertained.
 - 4.5** Entrance examination will be held at ARDE, Pune or at suitable place in Pune allotted by Third Party Aggregator (TPA). Exact dates will be intimated to the applicants in due course of time.
 - 4.6** It is mandatory to submit the following documents/information online along with the application : (i) ITI certificate and marksheet (ii) High school/equivalent certificate and marksheet (iii) Handicap certificate (if applicable) (iv) Recent passport size photograph (v) Aadhar card (vi) PAN Card (vii) Individual's signature on plain white paper (viii) Email ID (ix) Mobile no
 - 4.7** Window for online application will be closed on **30th May 2023**.

5. **PROCEDURE FOR REGISTRATION AND SUBMISSION OF APPLICATION :** Candidates need to register themselves on apprenticeship portal www.apprenticeshipindia.gov.in. After registration they should apply for apprenticeship in their own trade. Please note that registration on government portal is necessary.
6. **BOARDING/LODGING: No boarding or lodging expenses are admissible. However selected candidates can have lunch, tea, snacks etc at canteen facility at ARDE on payment basis.**
7. Upon completion of the Apprenticeship period ARDE shall have no obligation to offer employment to such apprentices nor can an apprentice claim right for employment on the grounds of completion of Apprenticeship.
8. Candidates must have taken fully vaccinated 02 doses & Booster dose/Precaution dose at the time of attending the interview. Candidate must carry with them the covid-19 vaccination certificate issued by the Ministry of Health & Family Welfare, Govt. of India.
9. Stationary items such as clip boards, Pen, Pencil, etc are to be brought by the candidates.
10. TA/DA and boarding/lodging facilities will not be provided by TPA or by ARDE, Pune.
