To fuel its ambitious growth plan NTPC is looking for promising, energetic, young professionals with brilliant academic record to join the organization as **Assistant Chemist Trainee (ACT)**. The qualifying requirements are as under:

POST : ASSISTANT CHEMIST TRAINEES (ACT) - 30 POSTS

Qualification: Full Time/Regular M.Sc in Chemistry with at least 60% marks from recognized Indian University/ Institute recognized by appropriate statutory authority. Final year / semester students who expect their result by 31.08.2023 can also apply. SC, ST and PwBD candidates with pass marks in qualifying examination are eligible to apply for the post.

Upper Age Limit: 27 years as on the last date of application.

Compensation Package: Selected candidates will be paid a stipend of Rs. 30000/- per month, with free bachelor accommodation and medical facility for self, during one-year training. These candidates will be absorbed after successful completion of training in the pay scale of Rs. 30000-120000 at the basic pay of Rs. 30,000/- (E0 Grade). The other benefits such as Dearness Allowance, other perquisites and allowances, terminal benefits, etc. will be admissible as per company rules in force from time to time after absorption.

HEALTH : The candidate should have sound health. Before joining, candidates will have to undergo medical examination at any of the NTPC hospitals and the decision will be final and binding. No relaxation in health standards is allowed. Detailed medical norms are available on the website careers.ntpc.co.in

GENERAL CONDITIONS:

- Only Indian Nationals are eligible to apply.
- All qualifications should be from Universities / Institutions recognized and approved in India.
- Computations of age shall be done w.r.t. the last date of receipt of online application as mentioned in the advertisement. The date of declaration of result / issuance of marksheet shall be deemed to be the date of acquiring the qualification and there shall be no relaxation on this account. Final year / semester students who expect their result by 31.08.2023 may also apply, however, they must be able to produce final marksheet/course completion certificate/provisional degree with minimum 60% marks (pass marks for SC/ST/PwBD candidates) on or before 31.08.2023.
- Eligible candidates will have to appear for All India Online Selection Test. Based on category wise merit; candidates will be shortlisted for document verification. The test will be consisting of two parts - Subject Knowledge test and Executive Aptitude Test. The candidates have to qualify separately in both parts.
- Candidates have to choose a test center for online selection test. However, NTPC reserves the right to cancel or add any center depending on the response of the candidates for that area / center.
- Candidates claiming to belong to any particular category shall necessarily have a valid EWS/OBC/SC/ST/Disability certificate, as the case may be from the Competent Authority (in the prescribed format of Government of India). Where there is vacancy identified for such category, upper age limit is relaxed by 5 years for SC/ST candidates, by 3 years for OBC candidates, by 10 years for PwBD candidates, 5 years age relaxation for candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period 01.01.80 to 31.12.89. Relaxation of age to Ex-Serviceman as per Govt. guidelines.
- Depending on the requirement, the Company reserves the right to cancel / restrict / curtail / enlarge the number of vacancies, if need so arises, without any further notice and without assigning any reason thereof.
- Posting shall be at any of the Stations/ Projects/ JVs/ Subsidiaries of NTPC. All posts are transferable at the sole discretion of the Management.
- While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above, as on the specified dates and that the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his/her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment his / her services are liable to be terminated without any notice. Canvassing in any form shall disqualify the candidate.
- The mere fact that a candidate has submitted application against the advertisement and apparently fulfilling the criteria as prescribed in the advertisement would not bestow on him/her the right to be considered further for selection process.
- The selected candidates who belong to General/EWS/OBC categories will be required to execute a service agreement bond of Rs. 1,00,000/- (Rs. 50,000/- for candidates belonging to SC, ST, PwBD categories) to serve the company for at least 3 years after successful completion of one year training.

HOW TO APPLY

Interested candidates should log on to our website careers.ntpc.co.in or visit careers section at www.ntpc.co.in for applying. No other means/ mode of application shall be accepted. Candidates are required to possess a valid email ID. NTPC will not be responsible for bouncing back of any email sent to the candidates. Candidate belonging to General/EWS/OBC category is required to pay a non-refundable application fee of Rs. 300/-. The SC/ST/PwBD/XSM category & female candidates need not pay the application fee.

Payment in offline mode: State Bank of India has been authorized to collect the application fee, in a specially opened account (A/C No. 30987919993) at CAG branch, New Delhi (Code: 09996), on behalf of NTPC. Candidate has to approach the nearby SBI branch with a printout of the "pay-in-slip" which is available on the application portal. The pay-in-slip printed from the portal should only be used for depositing the fee for proper crediting of amount in the allocated account. On receipt of the money, the bank will issue a unique Journal Number and a Branch Code of the bank collecting the money. This journal number and the branch code are to be filled up by the candidate during online application. NTPC will not be responsible, in case a candidate deposits the fee in wrong account.

Payment in online mode: Candidates also have the option to pay the fees online (through Net banking / Debit Card / Credit Card). The online payment option will be available in the online application form.

Fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility criteria before paying the application fee. After applying online, candidate is required to download the application slip generated by the system with unique application number. Copy of application slip may be retained by the candidate for future reference. No document is required to be sent to us by post.
