The merit list of the candidate shall be determined as per order of preference indicated by the candidate for particular post(s).

#### 1. EXAMINATION FEES AND MODE OF PAYMENT:-

- i. A Non-Refundable Fee of  $\stackrel{\blacktriangleleft}{=}$  150 for APST candidates and  $\stackrel{\blacktriangleleft}{=}$  200 for GENERAL candidates (to be paid online only).
- ii. Persons with Disabilities (PwD) are exempt from paying the fees.

#### 2. ELIGIBILTY CRITERIA:

- i. The candidate must be a citizen of India.
- ii. The educational qualification, age, experience as stipulated in the advertisement shall be determined as on the closing date of submission of application.

#### 3. SCHEME OF EXAMINATION:-

The scheme of examination will consist of two stages against posts indicated below:

#### Only Stage-1:

## Stage- 1 (Objective Type Multiple Choice Questions) 300 Marks:

The test will comprise of the following subjects:

## (a) General English – 100 marks (50 questions of 2 marks each)

Syllabus:-Spot the Error, Fill in the Blanks, Synonyms/ Homonyms, Antonyms, Spellings/ Detecting mis-spelt words, Idioms & Phrases, One word substitution, Improvement of Sentences, Active/ Passive Voice of Verbs, Conversion into Direct/ Indirect narration, Shuffling of Sentence parts, Shuffling of Sentences in a passage, Cloze Passage, Comprehension Passage.

## (b) Elementary Mathematics - 100 marks (50 questions of 2 marks each)

Syllabus:-i) Number Systems: Computation of Whole Number, Decimal and Fractions, Relationship between numbers.

- ii) Fundamental arithmetical operations: Percentages, Ratio and Proportion, Square roots, Averages, Interest (Simple and Compound), Profit and Loss, Discount, Partnership Business, Mixture and Allegation, Time and distance, Time and work.
- iii) Algebra: Basic algebraic identities of School Algebra and Elementary surds (simple problems) and Graphs of Linear Equations.
- iv) Geometry: Familiarity with elementary geometric figures and facts: Triangle and its various kinds of centres, Congruence and similarity of triangles, Circle and its chords, tangents, angles subtended by chords of a circle, common tangents to two or more circles.
- v) Mensuration: Triangle, Quadrilaterals, Regular Polygons, Circle, Right Prism, Right Circular Cone, Right Circular Cylinder, Sphere, Hemispheres, Rectangular Parallelepiped, Regular Right Pyramid with triangular or square Base.
- vi) Trigonometry: Trigonometry, Trigonometric ratios, Complementary angles, Height and distances (simple problems only) Standard Identities like  $\sin^2\Theta + \cos^2\Theta = 1$  etc.
- vii) Statistical Charts: Use of Tables and Graphs: Histogram, Frequency polygon, Bar-diagram, Pie-chart.

## (c) General Knowledge - 100 marks (50 questions of 2 marks each)

Syllabus: Questions are designed to test the candidate's general awareness of the environment around him and its application to society. Questions are also designed to test knowledge of current events and of such matters of everyday observation and experience in their scientific aspect as may be expected of an educated person. The test will also include questions relating to India and its neighboring countries especially pertaining to History, Culture, Geography, Economic Scene, General policy and scientific research, National/International Organizations/Institutions etc. State specific questions may also be asked.

. The test will be of Objective Type Multiple Choice Questions comprising of 150 questions as mentioned above. Each question will carry 02(two) marks. The candidate will have to complete the test in 03 (three) hours.



- . A candidate must secure a minimum of 33% in each subject in the written examination paper. The candidate securing less than 33% of marks in any of the subject shall be deemed not eligible for selection. **There is no negative marking.**
- . The total number of candidates shortlisted for Stage 2 (Skill Test) will be in 1:3 ratio i.e., if total vacancies are 10 then 30 candidates will be shortlisted for Stage 2, subject to the candidate securing a minimum of 33% marks in each subject in the written Examination paper.

## Stage- 2 (Skill Test):

A Skill Test of qualifying nature will be conducted comprising of the following:

## Typing Test

Typing Speed test of 35 words per minute on computer (35 words per minute corresponds to 10500 Key Depression per hour) (KDPH) on an average of 5 Key Depression for each word.

#### Note:

- Only the shortlisted candidates from Stage-1 as per the prescribed ratio will be allowed to appear for Stage-2 i.e. Skill Test.
- Skill Test will be of Qualifying nature only, the marks secured will not be counted for preparation of the final Merit.
- The candidate must Qualify in Stage-2.
- Other details, if any, of Skill Test will be informed in the official website.
- Stage-2 (Skill Test) of the examination is not applicable for candidates for the post of Agriculture Field Assistant Jr. (AFA Jr.) (10/23) and Dissection Hall Attendant (14/23).
- The Final merit for all the posts shall be prepared on the basis of marks secured in written examination only.
- 4. HOW TO APPLY: Candidates are required to apply online through the website www.apssb.nic.in.

- 6. THE SHORTLISTED CANDIDATES WILL HAVE TO SUBMIT COPIES OF THE FOLLOWING DOCUMENTS/INFORMATION TO THE BOARD DURING DOCUMENT VERIFICATION.
  - i. Recent passport size Photograph.
  - ii. Matriculation certificates issued by the Board/University for proof of date of birth.
  - iii. Class XII pass certificate issued issued by the Board/University.
  - iv. Class XII marksheet issued by the Board/University.
  - v. APST Certificate (if applicable).
  - vi. Certificate of 6 months Diploma in Computer Application from a recognized Board/Institution duly recognized by the Arunachal Pradesh Council for Technical Education/ AICTE (if applicable).
  - vii. Certificate of 1 (one) year Diploma in Computer Application (if applicable).



- viii. Intimation letter to HoD for those who are in regular Govt. Service.
- ix. PwD certificate in case of vacancy under PwD quota.
- x. Admit Card and printout of online application form.
- xi. Any other documents as may be relevant.

Shortlisted candidates will have to produce the above mentioned Certificates/Documents and mark sheet in original during document verification failing which his/her candidature will be summarily rejected.

#### NOTE:-

- i. There is no provision of re-evaluation /re-checking of Answer Sheet /Answer Scripts in respect of the examinations conducted by APSSB.
- ii. The APSSB reserves the right to cancel/withdraw any question/questions from the Test.
- iii. The Board makes provisional selection of the candidates on the basis of information provided in the application and documents/certificates provided by the candidate at the time of submission of documents and recommend the same to the indenting/ user department. Further, the Appointing Authority i.e. the indenting/user department verifies and satisfies itself about the authenticity of documents/certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional selection of a candidate does not confer upon him/her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
- iv. The Board reserves the right to conduct medical test for examining the candidates belonging to PwD category if it deems necessary.

ii. The Board will endeavour to accommodate the candidates in centres opted by them. However, the Board reserves the right to cancel any Centre and ask the candidates of that centre to appear from another centre. Board also reserves the right to divert candidates of any centre to some other Centre to take the examination without citing any reasons.

#### 9. GENERAL INSTRUCTIONS FOR CANDIDATES:-

- i. The vacancies published are provisional and subject to change. The Board reserves the right to increase or decrease the vacancies for any post in any category due to administrative reasons or in public interest. In case the vacancy position is reduced to any number or even withdrawn by the user department, the Board shall not be liable to compensate the applicant for any consequential damage/loss.
- ii. The Board reserves the right to reject the candidature of any candidate at any stage of recruitment.
- iii. The Board reserves the right to cancel a part or entire process of examination or a part of it due to administrative reason(s) and in case of unfair means, cheating or other irregularities / malpractice noticed by the Board. The Board also reserves the right to cancel or set up a new examination centre and divert the candidates to appear at that examination centre, if required.
- iv. The Board reserves the right to cancel any centre of exam and ask the candidates of that centre to appear at another centre. The Board also reserves the right to direct the candidates of any centre to another centre to take the exam. No request for change in date, time and centre of exam will be accepted under any circumstances.
- v. The Board reserves the right to change or make amendment in the examination scheme at any time before the examination, if so required.
- vi. The candidature of the candidate to the written examination is provisional and subject to the outcome of any direction/decision/order/pronouncement of any Court of Law and mere issue of Admit Card or appearance at the examination does not entitle him/her to any claim for the post.
- vii. No request or representations will be entertained for issuance of admit cards after closing date for download of admit cards.
- viii. The applicants are advised to fill up the application form carefully. They will not be allowed to edit/modify the details after the closing date. Application with incomplete or invalid details will be summarily rejected.
- ix. In case an applicant applies multiple forms for the same post, only the latest application form shall be considered by APSSB.

In case any candidate is caught / found in possession of any gadget/instrument, he/she would be debarred from the examination and legal proceedings shall also be initiated against the candidate.

- xiii. If any candidate uses offensive/abusive/foul language/obscene picture, he/she will be liable for necessary penal action under relevant provision of the IT Act.

xv. Candidates are advised to keep track of the Board website www.apssb.nic.in for any latest information related to the examination.

xvi. All concerned shall note that the Board has established series of checks to ensure that there is no impersonation and mischief. The selected candidates will be subjected to detailed scrutiny including document verification and biometrics. Candidates may also note that their candidature is provisional and if at any stage of examination, they are found involved either in violating any of the guidelines or found involved in any malpractices like impersonation, using unfair means etc. then strict action shall be taken against them which may include police action, lodging of FIR and debarment from all future examinations conducted by APSSB.
