- Selection to the post(s) is purely contractual, and it is terminable from either side with one-month prior notice. Selection to these posts does not confer the right of confirmation or continuation.
- In case of non-availability of suitable category candidates, the seat(s) may be filled up for less than 45 (Forty-Five) days by any candidate(s) belonging to other category.
- Reservation will be regulated as per guidelines issued from Govt. of India on time to time bring.
- Post(s) are not carried forward / considered as backlog vacancy in case of unfilled EWS category seats.
