1. The recruitments will be purely on contractual basis and the selected candidates will have no claim for regularization of the service in the ESIC hospital Korba .
2. Candidates seeking Reservation / Age relaxation benefits under SC/ST/OBC(NCL) category must ensure that they are entitled to such reservation as per eligibility prescribed in the notice and as per the instruction issued by Government of India. They should also be in possession of the certificates in the prescribed format of Govt. of India in support of their claim. Candidates seeking reservation under EWS category, should submit their EWS certificate as prescribed vide Govt. of India, Department of Personnel & Training OM No. 36039/1/2019- Estt.(Res) dated 31-01-2019. Candidates claiming reservation/age relaxation under OBC (NCL) candidates are required to submit latest OBC Certificate as per Central Govt. Proforma (not more than one year old) from the date of Interview.
3. If no eligible candidates are available against the respective categories mentioned as above, then any candidate may be considered for walk-in-interview irrespective of category, for engaging Senior Residents for 39 days extendable by another 39 days subject to fulfillment of Essential Qualifications and other conditions. against reserved posts for SC, ST & OBC as per order No.36036/3/2018 Estt. (Res.) dated 15.05.2018 of Govt. of India. The contract will be renewable with further advertisement in absence of reserved candidates.
4. Private practices of any kind will not be allowed for full time contractual Specialist and Senior residents.
5. ESIC may increase or decrease or cancel filling up of any or all the post without assigning any reasons at the discretion of the Appointing Authority. 10. Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage.
11. Hostel accommodation/ quarters will not be provided.
12. The candidate who is in service should submit "No Objection Certificate" from the employer at the time of interview.
13. The posts are contractual and the contractual engagement may be terminated/ discontinued by either side by giving one month's prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
