- 1. The posts carry all India service liability. Therefore, those who are willing to serve anywhere in India may only apply.
- 2. The applicants who apply for the post with respect to the advertisement shall not be allowed to withdraw his/her candidature subsequently. The applicant selected by NHAI should not decline the offer of appointment.
