3.4 Additional acceptable sports achievement eligibility norms for Specfic disciplines only.

3.4.1 Athletics (Men & Women):-

In Athletics, medal winning performance in National Inter State Senior Athletics Championship, may also be considered for recruitment against the posts in level 2. (Grade Pay Rs. 1900/- in Pay Band Rs. 5200-20200.)

In Athletics, Gold medal winner in Open National Championship (Senior), Inter State Athletics Championship (Senior) and Asian Championship (Senior) may be considered for recruitment in Level 5/4 (GP Rs. 2800/2400)

3.4.2 **Cricket:**-

In Cricket (Women) at International level, representation of Main Indian Seniors team in a Test Match or in a Limited Overs One Day International Match or in a Twenty-20 Overs match: shall also be considered for recruitment against the posts in 3/2. (Grade Pay Rs. 1900/- Or Rs. 2000/- in Pay Band Rs. 5200-20200)

3.4.5 **Volleyball (Men & Women):**

Sports achievements in the event conducted by Volleyball Federation of India or its affiliated units after 02/01/2017 will not be considered.

However, the certificates issued by the Associations of Indian Universities and the International Federations for recognized sports achievement in the game of Volleyball will be permissible.

3.4.6 **Powerlifting(Women)**:

Sports achievements in the event conducted by Indian Powerlifting Federation (IPF) or its affiliated units after 03/10/2017 will not be considered.

However, the certificates issued by the Associations of Indian Universities and the International Federations for recognized sports achievement in the game of Powerlifting will be considered.

3.4.7 **Handball (Men):**-

Sports achievements in the event conducted by Handball Federation of India or its affiliated units from 31/12/2021 to 25/7/2023 will not be considered.

However, the certificates issued by the Associations of Indian Universities and the International Federations for recognized sports achievement in the game of Handball will be considered.

3.4.8 **Hockey (Men):**-

Hockey India may be treated as the recognized National Sports Federation for the game of Hockey.

3.4.9 In Rifle Shooting,:-

A. Only the individual performance in recognized domestic Championship shall be considered for recruitment purpose. All India G.V.Mavlankar Shooting Championship is not a recognized championship for this purpose.

B. On the basis of performance in National Shooting Championship Competitions, only the "National Championship" should be considered as recognized category. Hence "Civilian Championship" is not recognized for recruitment purpose.

- 4.1 Fee payment will have to be made online through payment gateway as part of online application process.
- 4.2 After ensuring the correctness of the particulars in the application form, candidates are required to pay fees through the payment gateway which has been integrated with the online application. No change / edit option will be allowed thereafter.

7 **ONLINE APPLICATION**

- 7.1 Candidates are required to apply ONLINE by visiting <u>www.rrc-wr.com</u>.
