

**1. QUALIFICATION:** A Post Graduate Degree i.e. MD/MS/DNB/DM/M.Ch or equivalent in the above Department recognized by Medical Council of India / NMC/ NBE.

#### 2. AGE LIMIT:

The upper age limit for applying these posts is 45 years.

Cut-off date to determine eligibility in terms of age of candidates will be the last date on 04-03-2024

SC/ST/OBC/PWBD candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation or relaxation in cut off marks which are otherwise allowed to those belonging to these categories. Further, reserve category candidates (SC/ST/OBC/PWBD) who become eligible by virtue of age relaxation applicable in their will be consider only for reserved seats of the category to which they belong even if they have the merit to be considered otherwise for UR.

Age relaxation is permissible to various applicants is as under: -

- 1. SC/ST- 5 years
- 2. OBC 3 years
- 3. PWBD- 10 years
- 4. Ex Servicemen Candidate- 5 years.

#### 3. APPLICATION FEES & MODE OF PAYMENT:

➢ General/OBC Category : Rs 1500/-SC/ST/EWS Category : Rs 1200/-

Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Application fee is required to be remitted through Demand Draft only. The **Demand Draft should be drawn in favour of AllMS, Patna payable at AllMS, Patna**. Any other instrument of payment is not acceptable. The application fee is non-refundable.

#### 4. FILLING UP OF APPLICATION FORM ON THE DATE OF WALK-IN INTERVIEW:

- a) For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (original and one set of self-attested copies) which also needs to be produced at the time of walk-in interview:-
  - Recent Passport size photograph of candidate
    - face clearly visible
    - The picture should be in colour, against a light-coloured, preferably white background
    - Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it
      must not cover your face.
  - Demand Draft in original (if applicable)
  - Aadhar Card
  - Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
  - MBBS Degree Certificate
  - Internship Completion Certificate
  - ➤ MD/MS/DNB/DM/M.Ch Degree/Provisional Degree Certificate
  - UG & PG NMC/State Registration Certificate
  - > Category/PwBD Certificate (If seat is claimed in reserved category)
  - Experience Certificate, if any
  - NOC from present employer (applicable for those working in Govt./Pvt. organization)
  - > Demand Draft in original
  - Any other relevant documents (viz. Research Work, Publication etc.)
- b) The candidates are requested to fill the correct details regarding name/age/gender/caste/address/educational qualification and other relevant fields mentioned in the application form.
- c) Once form is submitted, there shall be no provision for making changes in the application form.
- d) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

#### 5. RESERVATION:

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 5% for PwBD candidates (on horizontal basis).
- For OBC-NCL Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application from 05-03-2023 to 04-03-2024 (both dates inclusive). Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/ Govt. of India or for the appointment to the Central Government Job.

#### 8. <u>SELECTION PROCESS:</u>

- a) Selection to the advertised posts of Senior Residents will be entirely done through the "Walk-in Interview" to be conducted on 05-03-2024; 09:00 AM onwards.
- b) All Candidates must provide phone numbers and E-mail for faster communication.
- c) Those who have already completed 03 years of their Senior Residency, are not eligible to apply.
- d) Qualification/Experience will be counted as on 04-03-2024
- e) The final result will be displayed on the website i.e. (www.aiimspatna.edu.in).
- f) Eligibility is subject to verification of the documents on the day of Walk-in Interview.

#### 9. METHOD OF RESOLVING TIES:

#### 10. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

- iii. Non-payment of application fees through Demand Draft, if not otherwise exempted.
- iv. Fee not paid as per instructions.
- v. Under aged/over aged candidates.
- vi. Failure to bring (in original) all relevant Certificates/Documents issued by the competent authority, along with self-attested legible copies in support of the information given in their Application Forms about their Educational Qualifications; Experiences; Percentage of Marks obtained; Proof of Age; Proof of Category [SC/ST/OBC/EWS/PwBD] at the time of Walk-in Interview and/or verification of document.
- vii. Not having the requisite Educational Qualification/Experience/Category Status as on **04-03-2024**
- viii. Incorrect information or misrepresentation or suppression of material facts.
- x. Any other irregularity.

#### 11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:
